**Program Summary**

**Between December 19, 2023 and June 28, 2024; Qualifying Dealers will be eligible to offer bona-fide end users \$750 in rebate credits for qualifying in-season stocking models.**

Additional terms and conditions apply.

**Dealer Qualifications**

To be eligible to participate in the Program, Dealers must:

- (1) Have a current and valid executed Arctic Cat Dealer Agreement authorizing dealer to sell the listed Models above in the Region;
- (2) Dealer participated in the MY24 snow ordering period; AND
- (3) Dealer has a Wells Fargo floorplan finance agreement in place and in good-standing.

**Qualifying Retail Sales**

A Qualifying Retail Sale under the Program must meet the following conditions:

- Program;
- (1) Dealer has made a retail sale of a Select In-Season Model Vehicle to a bona-fide end user; Rebate not eligible for bona-fide end user units ordered within the MY24 Snowmobile Pre-Order Program;
  - (2) The purchased vehicle is invoiced at or above the Manufacturer's Minimum Advertised Retail Price, before any in-store rebate is applied;
  - (3) Dealer has applied an in-store instant rebate to the customer's negotiated price, as reflected on the invoice, of \$750; and
  - (4) The vehicle is warranty registered to the bona-fide end user on the final invoice within seven (7) days of the retail sale.

**Receiving Benefits**

Rebate credits will be applied to dealers open account following:

- (1) Warranty Registration;
- (2) Verification of qualifying In-Season model to bona-fide end user;
- (3) A \$750 rebate applied to dealers open account.
